## Sweepstakes Official Rules

**NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN THIS PROMOTION.** A purchase will not increase your chance of winning.

**1. PROMOTIONAL PERIOD.** This Voice of the Customer Elizabethtown Gas Sweepstakes (the "Promotion") commences on **January 1, 2026**, at 12:01 a.m. and ends on **December 31, 2026**, at 11:59 p.m. (the "Promotional Period").

**2. WHO IS ELIGIBLE.** The Promotion is open to all legal residents of the United States. The employees, agents, directors, officers, and contractors of the following entities are not eligible to participate in this Promotion (the following entities being the "Promotional Entities"): (a) Elizabethtown Gas Company; (b) the advertising, fulfillment, judging, and promotional agencies involved in the development and administration of this Promotion; and (c) the parents, subsidiaries, and affiliated companies and distributors of the foregoing entities. The immediate family members (spouse, parent, child, sibling, and their respective spouses and children, regardless of where they reside) and household members (whether or not related) of the employees, agents, directors, officers, and contractors of the Promotional Entities are not eligible to participate in this Promotion. This Promotion is void outside the United States and where prohibited by law.

(a) Elizabethtown Gas Company; (b) the advertising, fulfillment, judging, and promotional agencies involved in the development and administration of this Promotion; and (c) the parents, subsidiaries, and affiliated companies and distributors of the foregoing entities. **3. HOW TO ENTER.** The Promotion must be entered by completing the Voice of the Customer survey using the online form provided on this Promotion site. The entry must fulfill all sweepstakes requirements, as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Elizabethtown Gas Company. Limit one entry per person, regardless of the manner of entry. Entries received outside of the Promotional Period will not constitute an entry into the Promotion. Each entry must be submitted in the name of an individual person. Entering the Promotion does not mean the entrant has won a prize. Entrants may not enter more times than indicated by using multiple email addresses, identities or devices in an attempt to circumvent the rules. If an entrant uses fraudulent methods or otherwise attempts to circumvent the rules, the submission may be removed from eligibility at the sole discretion of the Sponsor. The Sponsor is not responsible for misdirected, unintelligible, incomplete, lost, or late entries, or for technical, hardware, or software failures, lost or unavailable network connections, or failed, incomplete, garbled or delayed computer transmissions or other errors or problems of any kind associated with submitting an entry.

**4. PRIZE DRAWING.** Winners will be selected in random drawings on or about the 10<sup>th</sup> day of each following month from among all eligible entries received for the preceding month.

**5. PRIZE WINNER NOTIFICATION & REQUIREMENTS.** The potential winners will mailed their prize to the address on file with the Sponsor to the address supplied at the time of entry. In the event the prize is returned, the address is insufficient or incomplete for shipping purposes, or deliverable for any reason, the prize winner will be disqualified, and the Sponsor reserves the right, but does not have the obligation, to award the prize to an alternate entrant who will also be selected randomly, even if the disqualified potential winner's name was publicly announced.

The receipt by winner of the prize offered in this Promotion is conditioned upon compliance with any and all federal and state laws and regulations. **7. PRIZE TERMS.** All taxes are the sole responsibility of the winner. The odds of winning a prize are one out of the total number of eligible entries received. Sponsor reserves the right at its sole discretion to suspend, modify, or terminate the Promotion for any reason, including, but not limited to, should any portion of the Promotion be, in Sponsor's sole opinion, compromised by computer viruses, non-authorized human intervention, or other causes which, in Sponsor's sole opinion, corrupt or impair the administration, security, or fairness of the Promotion. If so terminated, Sponsor may (but has no obligation to) randomly select the winner from among all eligible, non-suspect entries received prior to termination, or take other action the Sponsor deems fair and reasonable. Automated entries are prohibited and any use of automated devices will cause disqualification.

**10. **13. GOVERNING LAW.** This Promotion is governed by the laws of the State of New Jersey, without respect to conflict of law doctrines.

**14. GENERAL TERMS.** If any term or condition of these Official Rules is invalid or unenforceable, then the term or condition may be modified or amended by the Sponsor to render it enforceable to the maximum extent permitted; if modification or amendment is not practicable, then the term or condition shall be severed from these Official Rules with no effect upon the remaining provisions. These Official Rules state the entire agreement between the Sponsor and the entrant. These Official Rules do not confer any rights or remedies upon any person other than the Promotional Entities and the entrants. The Promotional Entities will not be considered in default under these Official Rules to the extent that their performance is delayed or prevented by events outside such entities reasonable control. The failure of Sponsor to insist upon the performance of any provision hereof or to exercise any right or privilege granted hereby will not be construed to be a waiver of such provision, right, or privilege. These Official Rules shall be binding on the entrant and his or her heirs, executors, administrators, and successors and permitted assigns.
